The Links program offers certain Prometheus tests at a reduced cost to eligible applicants. The PROMETHEUS\* Anser\* and PROMETHEUS\* Monitr™ Crohn's Disease Tests are excluded from participating in the Links program in specific instances. For more information, please call Prometheus at 888-892-8391. Eligibility is based on household income and insurance status. Residents of the United States, District of Columbia, and Puerto Rico are eligible to apply. Please be aware these programs do not constitute health insurance. You must meet certain income requirements set forth above. Prometheus will request documentation to verify your income, including recently fi led tax returns and other supporting documentation. By requesting assistance, you certify, to the best of your knowledge, that you are eligible for assistance and that you have insufficient financial resources to pay for the ordered test. Many scenarios can occur when billing insurers, so please contact our experts and we will work with you. Prometheus may discontinue or change this program at any time or for any reason without notice.
